- **Competition Cancellation – No refund.**
- **No entries will be able to be transferred to a later show date.**
- **Dress is casual, tall boots or paddock boots with half chaps allowed, protective vest is mandatory on the cross country course**
- **Cross Country schooling -- ONLY with coach \$25.00 prepaid or \$35.00 day of show -- After show ONLY! No refunds.**
- **Cross country course will be closed the Wednesday before each show date.**
- **\$50 invoice for un-returned pinnys, \$35 returned check fee**
- **NO unleashed dogs**
- **Vet & Farrier will be on call.**
- **Current Negative Coggins required with entry form.**
- Ride times will be posted on www.CampbellSpringsFarm.com the Friday morning before the show date.
